On behalf of the undersigned and each of the undersigned's children and other dependents, as well as each of their and the undersigned's respective heirs, beneficiaries, executors, administrators and assigns (hereinafter referred to as "**we**", "**us**" and "**our**"), the undersigned hereby acknowledges, certifies, represents and warrants that we are of good health and are aware that the participation in or attendance at Crusader Academy activities, events, tournaments, games, hockey school, practices and/or programs (collectively, "**Activities**") is associated with hazards, dangers and risks, each of which can be severe and which can result in death or permanent disability, including, without limitation, those related to:

- collisions with participants, attendants and objects, including sticks, face masks, pucks, skates, helmets, boards, doors, nets, ice and other surfaces (hereinafter referred to as "**Equipment**");
- concussions, bruises, sprains, cuts, scrapes, breaks, dislocations and injuries to eyes, teeth, face, head, spinal cord and other parts of the body;
- exposure to, infection by, or contraction of illness or disease (including COVID-19) by ourselves and others;
- variations or defects in Equipment or their operation;
- failure to properly use Equipment;
- exerting and stretching various muscle groups;
- vigorous physical exertion, rapid movements and quick turns and stops on ice while wearing sharp metal skates;
- strenuous cardiovascular workouts;
- anxiety; and
- travel to and from the Activities.

In partial consideration of the Crusader Academy Ltd. permitting our participation in and attendance at the Activities, the undersigned, on behalf of each of us, hereby:

1. freely accepts and fully assumes all such hazards, dangers and risks and the possibility of loss, injury, illness, concussion, disability, incapacitation, death, injury, property damage, cost or expense (hereinafter referred to as "**Losses**") resulting therefrom;
2. waives and agree to waive any and all rights, claims, actions and proceedings (hereinafter referred to as "**Claims**") that any of us have or may in the future have against any of Crusader Academy Ltd. and its affiliates and its and their respective directors, officers, employees, agents and representatives, and any volunteers in any way associated with the Activities (hereinafter referred to as the "**Crusaders Academy Group**");
3. releases and discharges, and agree to release and discharge, the Crusaders Academy Group from any and all liability and responsibility for Losses that any of us may suffer, sustain or incur as a result of our participation or attendance in the Activities due to any cause whatsoever, including any negligence, breach of contract, breach of statutory duty of care, or breach of the *Occupier's Liability Act* (Alberta), or other legislation or regulation, by any member of the Crusaders Academy Group; and
4. agrees to hold harmless and indemnify each member of the Crusaders Academy Group from and against any and all Claims for Losses suffered by any third party resulting from any of our participation or attendance in the Activities.
